Foreword

Since its foundation in January 2015, the Cyber Security Coalition has established an active and trustworthy network of cyber security experts from public services, private companies and academic institutions. It was the close collaboration with these members that made 2016's achievements possible. Several experience-sharing and working group sessions were held during which cyber-security peers discussed trends, risks, best practices and operational expertise.

Furthermore, the publication of a practical guide on incident handling and prevention (available in 3 languages) demonstrated the Coalition's commitment to advising public and private organizations. Recommendations related to policies and regulations, such as the European Network and Information Security (NIS) directive, are also being developed.

The Coalition promotes safer and more secure online behavior amongst the general public via a yearly national awareness campaign. In October, we launched 'Take Back the Internet', the largest-ever national campaign on cyber security, in partnership with the Centre for Cyber Security Belgium. The campaign urges citizens to scan and secure their computer, tablet and smartphone.

Our ambition for 2017 is to take this unique security coalition to the next level, becoming the ultimate collaboration platform in the fight against cybercrime in Belgium.

In addition to large corporations, we will also continue to focus on informing SMEs on how to protect themselves against threats such as data breaches and phishing. It is for this reason that we have developed a free Cyber Security Kit, which will be distributed in early 2017.
















Our Organization

The Steering Committee, consisting of representatives of the 4 strategic axes, oversee the scope and progress of the working groups.


OPERATIONS MANAGER


